





























ACHIEVING HOUSING STABILITY (SUCCESSFUL EXITS) HUD SYSTEM PERFORMANCE MEASURE 7A.1 Street Outreach Rate of successful exits has increased since 2017 but remain below 2015 baseline. Rate of successful exits remains slightly below national average. Opportunity: Expand use of targeted housing navigation, and rapid resolution strategies. Opportunity: Improve accuracy of destination reporting from street outreach program exits. Emergency Shelter, Safe Haven, Transitional Housing, Rapid Rehousing Local data shows consistent upward trajectory despite minimal net change at national level. Housing First may be under attack but it's working in Pima County Opportunity: Identify essential elements of high-performing projects and scale. Opportunity: Adapt services to support income to emerging confined job market.

Permanent Supportive Housing

- National gains are not being actualized in Pima County.
- Opportunity: Intensive targeted supportive services and permanency planning are needed.







MOST NOTABLE FINDING

On the night of the 2020 Point in Time count, we had enough vacant shelter and supportive housing beds to provide a safe place for every person identified as experiencing unsheltered homelessness.






















ALL PERSONS: KEY FINDINGS Homelessness is increasing in Tucson/Pima County. • Gains made between 2017 and 2019 reversed in 2020 for a net change of +86 since 2015. Net change in all homelessness between 2019 and 2020 was +288 (20.9%). Net change in unsheltered homelessness between 2019 and 2020 was +218 (60%). Opportunity: Maximize use of all available housing resources. • Opportunity: Expand use of navigation and diversion services. • Chronic homelessness is increasing at an even faster rate Net change in unsheltered chronic homelessness between 2017 and 2020 was +191 (341%). Net change in all chronic homelessness between 2017 and 2020 (+151) is more than double the net change in all homelessness during the same period. Opportunity: Evaluation Coordinated Entry prioritization to better address chronic homelessness. Opportunity: Expand mainstream partnerships with Managed Care Organizations and other housing systems for diversion. Sources: 2017-2020 TPCH Point in Time, GRM Shelter Data











IT'S WORKING

Survivors of Domestic Violence

- 154 persons counted in 2020
- Net change 2017-2020: -228 (-59.7%)
- 2.5x more likely to be sheltered than unsheltered

IT NEEDS WORK

Adults with Serious Mental Illness

- 425 persons counted in 2020
- Net change 2017-2020: +78 (+22.5%)
- Unsheltered net change 2017-2020: +128 (130.6%

Adults Living with HIV/AIDS

- 53 persons counted in 2020
- Net change 2017-2020: -31 (-36.9%)
- 88.7% sheltered
- 7.8x more likely to be sheltered than unsheltered

Chronic Homelessness

- 383 persons counted in 2020
- Net change 2017-2020: +158 (+70.2%)
- Unsheltered net change 2017-2020: +191 (+341%)
- 13.6% of longer-term housing residents experienced chronic homelessness.
