TPCH ELECTION OVERVIEW AND INSTRUCTIONS

The annual election for TPCH Continuum of Care Board and Committee members is underway. The information contained in this packet is provided to assist members of the TPCH General Council in making informed decisions regarding the candidates for vacant CoC Board and Committee which they choose to support through election. This packet contains seven sections.

- Page 2 Voting Membership Roster: This roster lists all TPCH members with current voting privileges as of August 8, 2020. These are the only members eligible to cast a ballot during the 2020 CoC Board and Committee election. If you believe your voting privilege is inaccurately recorded, please email tpch@tucsonaz.gov.
- Page 3 TPCH 2020-2021 Board Roster: This roster identifies seated CoC Board Members whose terms
 continue through the 2020-2021 year. Voting members are encouraged to consult this list and cast votes
 that bring diversity of expertise and experience to the CoC Board.
- Pages 4-7 Slate of Candidates: The slate lists candidates for the CoC Board and each committee.
- Pages 8-18 Board and Committee Candidate Matrices: These matrices identify all candidates for each elected body of TPCH. Each matrix includes demographic information as they relate to three areas of priority diversification within the Continuum of Care (leadership of persons with lived experience of homelessness and housing instability, diverse sexualities and genders, and Black, Indigenous, and other people of color). The matrices also reflect each candidate's reported areas of expertise in the areas established as priorities for each elected body through the TPCH Committee Composition Operating Policy.
- Pages 19-74 Candidate Statements of Interest: Statements of interest are provided for all candidates seeking election for the CoC Board and/or Committees. Candidate statements are organized in alphabetical order by last name.
- <u>Pages 75-78 TPCH Standing Committees</u>: The standing committee overview provides a brief description and highlighted responsibilities of each committee.
- Pages 79-80 Ballot Quick Reference: The Quick Reference is a resource provided to help voting members select candidates to elect with consideration for the overall representation of individual organizations and people within the CoC's elected bodies. Voting members are encouraged to elect a diverse representation of CoC Board and Committee members that reflect the variety of organizations, sectors, and roles that comprise our coalition.

VOTING INSTRUCTIONS

Only one ballot may be cast for each TPCH voting member identified in the membership roster. Multiple votes from the same agency will not be accepted.

Ballots may not include votes for more candidates than are eligible for election on any voting body. The ballot indicates the total number of votes that can be cast for each voting body.

No individual may serve on more than two elected bodies of the Continuum of Care (CoC Board + 1 Committee, or 2 Committees).

No agency may have more than two representatives seated on any elected body. If an agency has two elected representatives, each representative will have one vote on all actions taken by the elected body.

All ballots must be cast online no later than 11:59pm on Tuesday, August 18.

Late ballots will not be accepted.

In casting your votes, members of the TPCH General Council are encouraged to make choices which reflect the values and direction of the Continuum of Care:

- As part of our commitment to improving equity within the local homelessness response system, TPCH
 seeks to improve diversity in CoC leadership bodies through increased participation of people of color,
 LGBTQ+ people, and people with lived experience in CoC decision-making roles.
- TPCH is a broad-based coalition of non-profit service providers, government agencies, local businesses, faith communities, and community volunteers working together to prevent and end homelessness. We strive to build committees that reflect this diversity and encompass the entirety of our community's efforts to prevent and end homelessness.
- HUD Continuum of Care Program funds are just one part of our community's approach to ending homelessness and our leadership bodies should reflect the full breadth of services, funding streams, and approaches to this important work.

As a reminder, the following guidelines must be followed in casting your vote for TPCH committee members:

- 1. Organizational members may cast only one vote per entity.
- 2. No individual may serve on more than two committees (or one committee if the individual is also elected to the CoC Board).
- 3. No organization may have more than two individuals seated on any one committee. If two individuals from the same organization are seated on a committee, both will be eligible to vote on committee matters.

NOTES

There are five tables below, one for each of the TPCH committees elected by the TPCH General Council. Each table identifies committee candidates, primary organizational affiliation, whether the entity receives HUD Continuum of Care Program funding, and self-identified areas of expertise as they relate to the specific expertise sought for each committee and outlined in the TPCH CoC Committee Composition Operating Policy.

The table additionally includes a self-reporting of three characteristics identified as priorities in improving diversity and equity in TPCH decision-making:

- Lived experience of homelessness and/or participation in housing subsidy programs during lifetime
- Lesbian, Gay, Bisexual, Transgender, Queer, Gender Non-conforming/non-binary, and other people of diverse sexualities and genders
- Black, Indigenous, Hispanic/Latinx, and other People of Color

As a white women of lower socioeconomic status, I've experienced both privilege and discrimination. Coming from a poor, broken family (of which I was the black sheep), my childhood was filled with debilitating trauma- yet I was able to see that things could and should be better. Eventually I learned that I could be an agent of that change. Early on, I embraced the idea that it was my duty to use my voice to advocate for other marginalized people in my community. Professionally speaking this began in the 90's, as I managed and eventually owned a cab company. The people that worked for me were all outcasts to one degree or another and I felt it my moral obligation to create a safe working environment in which they could embrace their differences and thrive. This environment provided me with the support I needed to learn to believe in myself and I soon became my family's first college graduate.

In college, rather than pursue a degree/career path, I sought self development and Improvement through Second language acquisition. Becoming bilingual in Spanish and learning all I could about the history of colonization and oppression in Central and South America with a focus on the stories of the Maya changed my world completely. It gave me a keen appreciation of how language, race, gender, etc shape our identities and deeply effect how we experience our worlds.

In 2097, I moved from my midwestern hometown (thankfully a big 10 university-for the culture and knowledge a university atmosphere creates) to southern Florida where I spent 8 years managing social services programs in a small migrant farm working community- one of the poorest communities in our country. I oversaw a soup kitchen, food bank, shower program, farm working housing property and community center, and more. Programs all dedicated to addressing hunger and homelessness for the people that pick and package the fruits and vegetables that we eat each day.

It was during this time that I became of member of Collier County's newly formed Continuum of Care. I volunteered for Collier Harvest - delivering day old breads to other soup kitchens and homeless shelters, I volunteered for the Hunger and Homeless Coalition and advocates each day for donations to better serve the farm workers that couldn't afford to feed themselves.

When I moved to Tucson five years ago I knew I wanted to continue this work and found a position with Interfaith Community Services as a case manager overseeing their ESG finds and serving as the TPCH liaison. Until recently I worked as their Homelessness Prevention Services Manager.

Reason(s) Interested in Joining the CoC Board/Committee

While I am no longer working at ICS, I am deeply committed to working with people experiencing homelessness and continuing to advocate for/with folks experiencing marginalization and other-ness. I wholeheartedly believe in the work that the COC is doing and its role

	in addressing racial inequities in our homeless population. I believe that the work I did in Florida's with a largely undocumented population experiencing extreme poverty, food insecurity, and homelessness/housing exploration coupled with the work I've done here with prevention and diversion gives me a solid understanding of how deeply entrenched inequality is in our systems and how those of privilege benefit from the oppression of others—oftentimes while they are simultaneously giving of their wealth to supposedly ameliorate the sufferings of the impoverished. I want to help make a difference in our community. I understand the suffering that comes from hunger, homelessness, marginalization, and not having a sense of safety and belonging.
Current and Past Participation with TPCH or Other CoCs	As I mentioned above, I began working with the Continuum of Care model in 2009. In 2018 I became ICS's TPCH representative and sole HMIS user. I attended Coordinated Entry, HMIS, COS, ESS, and General Council meetings. I helped our directors stay in the know when it came time to vote. Over the last year I served as Chair of the Emergency Solutions Subcommittee and then worked with G&P to produce the committee restructuring recommendations to the Board.
Community Coalitions/Activities in Candidate Participates	Currently I'm serving on the DEI committee for the Arts Foundation. The looming eviction crisis was a topic of discussion in our last meeting as were "listening sessions" that the fairly new ED wants to have with stakeholders in the community. I recommended that she reach out to TPCH/CA To feel out the possibility of participating in one of these sessions. I'm certain that as these two committees grow there will be other opportunities to work together for the betterment of our community

System Performance Evaluation Committee (SPEC)

Composition

4 elected seats, 3 appointed seats, 2 appointed seats for persons with lived experience of homelessness within the past 5 years

Committee Responsibilities

- Compiling and reviewing data to improve the performance of the entire Continuum of Care.
- Analyzing and sharing system performance data with the CoC Board and membership.
- Overseeing the process of conducting an gaps analysis annually; reviewing and sharing data from the gaps analysis with the CoC Board and membership.
- Working to enhance and expand community-wide services based on identified gaps and community need.
- Recommending to the CoC board proven strategies for prioritizing the use of Emergency Solutions Grant (ESG) funds; acting as the liaison between and among City, County, and State ESG funding sources.
- Evaluate the performance of the CoC Lead/Collaborative Applicant and HMIS Lead at least annually, and report evaluation findings to the CoC Board.

Homeless Management Information Systems Committee (HMIS)

Composition

4 elected seats, 3 appointed seats, 2 appointed seats for persons with lived experience of homelessness within the past 5 years

Committee Responsibilities

- Reviewing and providing guidance to the CoC Board regarding TPCH's HMIS capabilities, software selection, and planning recommendations.
- Reviewing HMIS data quality to include data completeness and data accuracy and reporting this data to the CoC Board, membership, and HMIS participating agencies.
- Reviewing, updating, and overseeing policies and procedures concerning HMIS data and its use.

Tucson Pima Collaboration to End Homelessness Standing Committees (June 2020)

- Reviewing and recommending for approval the Point in Time Count, Housing Inventory Count, Annual Performance Report, Longitudinal System Analysis, System Performance Report, and other HUD data submissions to the CoC Board.
- Conducting on-going evaluation of HMIS system and gathering user feedback to improve the HMIS experience.

Continuum of Care Program Grant Committee (CoC)

Composition

4 elected seats, 3 appointed seats, 2 appointed seats for persons with lived experience of homelessness within the past 5 years. The Continuum of Care (CoC) Program Grant Committee shall be comprised of not more than 49% CoC Program grant recipients and/or subrecipients.

Committee Responsibilities

- Monitoring CoC recipient and subrecipient performance; recommending performance improvement plans to the CoC Board.
- Recommending priorities and community strategies related to the use of CoC Program funds to the CoC Board.
- Developing and recommending performance improvement targets for CoC projects consistent with the CoC's adopted system performance improvement strategies.
- Reviewing, updating, and overseeing the implementation of the CoC's approved reallocation policies.

Diversity, Equity, and Inclusion Committee (DEI)

Composition

6 elected seats, 5 appointed seats, 2 appointed seats for persons with lived experience of homelessness within the past 5 years

Committee Responsibilities

The Diversity, Equity, and Inclusion (DEI) Committee shall be responsible for:

- Collaborating with CoC Board and Lead Entities to plan and coordinate equity initiatives within TPCH with particular focus on issues of racial equity, LGBTQ+ inclusivity, and citizenship.
- Reviewing existing and proposed TPCH policies and practices; recommending strategies to increase representation from diverse stakeholders and prevent structural of systemic inequities prior to new policy adoption.
- Collecting and analyzing quantitative data regarding equity and inclusivity within the local homelessness response system.
- Issuing recommendations to improve equitable outcomes for all populations served through the local homelessness response system to the CoC Board.

 Collaborating with CoC Lead/Collaborative Applicant and HMIS Lead to issue periodic reports, at least annually, on efforts to address equity and inclusivity within the homelessness response system and the outcomes of those efforts.

Coordinated Entry Committee (CE)

Composition

4 elected seats, 3 appointed seats, 2 appointed seats for persons with lived experience of homelessness within the past 5 years

Committee Responsibilities

- Recommending policies and procedures to improve and expedite the CE process to the CoC Board.
- Engaging in on-going planning and evaluation of the CE system at least annually.
- Expanding housing and service linkages including but not limited to education and employment services within the CE system.
- Expanding and improving coordination among outreach, shelter, diversion, and homelessness prevention and eviction prevention resources within the CE system.
- Monitoring participation and utilization of the CE system among CoC and ESG projects; reporting participation and utilization information to the CoC Board.

Youth Action Committee (YAC)

Composition

10 appointed seats youth and young adults under the age of 25 with lived experience of homelessness and housing instability.

Committee Responsibilities

- Providing guidance and policy recommendations on the implementation, administration and oversight
 of services impacting youth who are experiencing homelessness or at risk of homelessness.
- Guiding ongoing planning of homeless youth services and oversee the Tucson/Pima County Coordinated Community Plan to Prevent and End Youth Homelessness.
- Providing a youth voice in decision making within the CoC.
- Developing and overseeing implementation of strategies to serve youth experiencing homelessness more effectively throughout the CoC.
- Assist in the development and design of applications for funding for youth homelessness projects.
- Integrating youth input throughout the CoC and coordinating youth focused activities with other committees, work groups, the HMIS Lead, and the CoC Lead/Collaborative Applicant.
